1 NOTIFICATION:

2 On 3/26/05 at 1135 hrs I was dispatched to this non injury traffic collision at Lake Forest
3 and Pittsford. Responding from Rockfield and El Toro, I arrived on scene at 1200 hrs. All times,
4 speeds, and measurements are approximate. Measurements were taken with a rolatape.

6 STATEMENTS:

Do not include statements of witnesses

7 D-1 (Laham) was interviewed at the scene and stated that he was traveling w/b Lake
8 Forest dr. #2 lane, and that he was approaching Pittsford. D-1 stated that he entered the
9 intersection of Pittsford with a green light and that, as he entered the intersection he felt impact to
10 the left rear portion of his vehicle.

11 D-2 (Kuraishi) was interviewed at the scene and stated that she was traveling e/b Lake
12 Forest dr. in the left turn lane and made a left turn with a green arrow. D-2 stated that next a car
13 (V-1) ran the red light and she impacted (broadside) the rear portion of the Saturn.

20 SUMMARY:

21 D-1 (Laham) was driving V-1 (Saturn) w/b Lake Forest #2 lane (approaching) intersection
22 of Pittsford. D-2 (Kuraishi) was driving V-2 (Honda) w/b Lake Forest in the left turn, and made a
23 left turn onto Pittsford with a green arrow. V-1 entered the intersection with a red signal, and was
24 broadsided by V-2. V-1 sustained minor left rear damage, while V-2 sustained minor frontal. Both
25 vehicles were driven away.

27 AREA OF IMPACT:

28 The AOI is 000 ft. w/ecl Pittsford, and s/ncl Lake Forest Dr. This was determined from both
29 drivers statements, as well as physical evidence (road scuffs).

31 CAUSE:

32 D-1 (Laham) caused this collision by being in violation of CVC 21453(a)-failure to stop for a
33 red light. This was determined from both driver's statements, as well as witness statements.

35 RECOMMENDATIONS:

36 Request prosecution of D-1.
