On Thursday, 23 June 2011, we came to the office of the Civil Unit of the Pierce County Sheriff's Department, located on the first floor of 930 Tacoma Avenue South, Tacoma, WA 98402, to serve summons on the Defendant of Small Claims Court Case 999310, MICHAEL S. LAHAM AND ELANA LAHAM VS SAWYER CORPORATE GROUP INC. We spoke to a Lorraine, and asked her to serve our summons on Kerry S. Bivens, President of Sawyer Corporate Group, Inc. Then, we showed her the Profit Corporation License Renewal & Annual Report for Sawyer Corporate Group, Inc., so that she could copy Kerry Biven's name and address from that sheet. After that, we changed our mind and requested that, instead of serving the summons on Kerry Bivens, we wanted it served upon the Registered Agent of Sawyer Corporate Group, Inc., who is James A. Krueger. We then gave Lorraine his address and telephone number.

On Friday, 1 July 2011, we received an affidavit of service of the above summons. The affidavit was dated Tuesday, 28 June 2011. It stated that the summons for Small Claims Court Case 999310 was served on a Ryan Sawyer, Vice-President of Sawyer Corporate Group, Inc. on 27 June 2011.

Later that same day, we went back to the office of the Civil Unit of the Pierce County Sheriff's Department. We told Lorraine that our summons had been served upon the incorrect party. We then requested, once again, that it be served upon James A. Krueger, the registered agent of Sawyer Corporate Group, Inc. Her reply was a) to insist that we told her to serve the summons on Ryan Sawyer and b) that it was O.K. to serve the summons upon Ryan Sawyer, Vice President of the Sawyer Corporate Group, Inc.

So we showed her the text of RCW 4.28.080 (9), which is the statutory law in the State of Washington that specifies on whom a summons must be served for a corporation. Nowhere in RCW 4.28.080 (9) does it allow service of a summons to go to a vice-president of a corporation. Her response was to bring out an attorney, named Craig S. Adams, who is the legal advisor for the Pierce County Sheriff Department.

He reiterated that it was O.K. to serve summons on a vice president of a

corporation and when we showed him the text of RCW 4.28.080 (9) he claimed that Case Law allows service of summons on a vice president of a corporation. After that, we asked him to give us a Case number and the references by which to look it up ourselves, so that we could verify that what he was telling us was correct. However, he refused, stating that to do so would be giving us legal advice, even though he already gave us legal advice when he claimed that it was O.K. to serve summons on a vice president of a corporation.

To check out the validity of the claim of Craig S. Adams, we looked up court cases in the appellate courts of the State of Washington and Supreme Court of the State of Washington presenting interpretation of RCW 4.28.080 (9) . The result of all five cases listed above was that the appellate courts and Supreme Court of the State of Washington ruled that the text of statutory law RCW 4.28.080 (9) is to be interpreted exactly as it reads – allowing service of a summons on a corporation on exactly those persons described therein and on no other persons. This makes it abundantly clear that service of a summons upon a vice-president of a corporation is NOT effective. As we had requested on Thursday, 23 June 2011, service of the summons for this case must be either on the president or the registered agent in order to be effective.

Therefore, to resolve this matter, we need the Civil Unit of the Pierce County Sheriff's Department to serve our summons again, without charging us any additional money, since it is the Civil Unit of the Pierce County Sheriff's Department who made the error. We need the Civil Unit of the Pierce County Sheriff's Department to serve our summons upon James A. Krueger, the Registered Agent for Sawyer Corporate Group, Inc., of Vandeberg, Johnson & Gandara, whose coordinates are:
