However, if you decide to do your job by instructing Judge Yunis Wedad to provide equal treatment to all parties who approach her bench by providing me with a translator, which according to Israeli Law I am entitled to have, and by ruling a verdict at the Susana Vexler versus Elana Laham Hearing according to the evidence and facts of the case then I will make positive posts about you on my web page for the entire Internet world to know about. Go to www.bullcrapbusters.com and click on "Updates 6/8/17" web page to see what the entire Internet world is reading about you. (See "Updates 6/8/17" web page fax attachment to this fax).

Due to the observation below, namely her breaking Israeli Law by denying me an English interpreter, the one and only reasonable conclusion that I, Elana Laham, can have is that Judge Yunis Wedad has taken a bribe from Susana Vexler to rule an unfair, unlawful verdict against me.

She made it obvious that she is biased against me because she is not willing to let me defend myself in a court of law, which is my legal right to do as an Israeli citizen. By not providing me with a translator, she is rendering me deaf to the Hearing and mute from being able to present my defense.

She said in her fax reply to my fax inquiry for a translator, "The defendant is entitled to come to the hearing accompanied by a friend.
