Judge Zahava Banar's letter stated that she "refer" me to mediation and included the name of a mediator, Danny Kafri, and his cell phone number of 050-8910222, and it was unclear to me what Zahava Banar meant by the word "refer". Is she ordering me to attend mediation, or is she suggesting I attend mediation?

The fact that Judge Zahava Banar is mentioning mediation to me at all and in such an untimely manner shows that she is ignoring the evidence that I submitted to the court in my statement of defense on June 5, 2017 for the Susana Vexler lawsuit.

Mediation is something a judge does for "he said she said" legal cases in which neither the plaintiff nor the defendant has any proof of their claims. So, the judge cannot determine who is in the right and who is in the wrong. Susana Vexler has presented zero evidence that I damaged her property. I have presented substantial evidence that I did not damage Susana Vexler's property. That being said, it is obvious that due to my evidence mediation is not appropriate for this legal case.
