

## SUSANA VEXLER LAWSUIT

**I DO NOT OWE SUSANA VEXLER ANY MONEY FOR DAMAGES TO HER DOOR OR DOOR LOCK FOR THE FOLLOWING REASONS:**

I received via registered mail the parcel containing Susana Vexler's Lawsuit (Case #26667-05-17) on May 24, 2017. **(See Israel Post Notice of Delivery)**

I had 15 days to submit a Statement of Defense. **(See Court Protocol Document)**

I submitted my Statement of Defense on June 5, 2017. **(See Court Receipt and Statement of Defense Form)**

**A) Susana Vexler wrongfully claims that I banged her door with a hammer. Therefore I damaged her door. Thereby I owe her money.**

**[The burden is upon the plaintiff to prove that the defendant owes money. All I received from Susana Vexler's lawsuit paperwork is a claim for damages to her property. Therefore, Susana Vexler has no evidence that I damaged her property. Thereby, even if I had no evidence that I did not damage Susana Vexler's property I owe her no money]**

**1) Susana Vexler's violent male visitor, Vitlay Zetzkav, Physically Attacked Me. I was afraid of him. So I did not go near her apartment. So I did NOT bang on her door with a hammer. Therefore I did NOT damage her door. Thereby I do NOT owe her money.**

Susana Vexler's violent male visitor, Vitlay Zetzkav, Physically Attacked Me. Twice, he forcefully entered my apartment without my permission by shoving me backwards into my own home. Then, he threw Susana Vexler's (pizza) trash from the hallway onto my chest. After that, he tried to hit me in the face with his fist but he missed. He physically attacked me wearing nothing but blue colored underwear.

**(See photo #1 of him staring at my closed apartment door with Susana Vexler's apartment door open)**

**a) I do not know why Vitlay Zetzkav Physically Attacked Me.**

I was putting a small nail into a wall that my apartment shares with Susana Vexler's apartment to mount a painting when he started banging on my door. When I opened my door he physically attacked me.

**(See photo #2 of the nail and photo #3 of the painting I was putting on my wall, which Susana Vexler's apartment and my apartment share)**

b) Vitlay Zezt kav also put a lock on the electric box so I cannot enter my side of the electric box to flip the electric switches to turn the electricity back on in my apartment if and when the electricity goes off.

**(See photos #4A and #4B of him putting a lock on the electric box)**

c) I requested a Protection Order against him. The Court granted me a ninety-day Protection Order against him, and extended the Protection Order to one year.

**(See Protection Order Verdicts – three months and one year)**

d) I live alone. My husband and I live separately. I will not leave my apartment without my husband being with me now as I am afraid of Vitlay Zetz kav.

**(See water bills with separate addresses)**

**[Vitlay Zetz kav is not a credible witness because he is not a neutral party as he is Susana Vexler's friend, and since he is violent and crazy as both Protection Orders testify]**

2) According to Susana Vexler's Lawsuit her door was hit with a hammer that made four holes in her door, and according to NP Doors Ltd estimate she is claiming that she has to have a new door lock.

a) But, no damage was done to the front of her door's lock.

**(See photos #5A, and #5B)**

b) And there are four shallow marks that only chipped off the door's finish. So the marks cannot have damaged her door's lock.

**(See photos #6A and #6B)**

c) And a hammer cannot damage a lock if the door is closed because the dead bolts are in the door jam. And a hammer cannot damage a lock if the door is open since the dead bolts are retracted (withdrawn) into the door.

d) Susana Vexler's Lawsuit states that the damage happened December 31, 2016. Yet the date of NP the Doors Ltd estimate for fixing her door's lock is May 11, 2017. If there was damage to her door's lock, why did she wait five months to make a claim that her door's lock must be fixed?

**(See NP Doors LTD estimate) (There is no bill)  
(See Susana Vexler's Lawsuit claim)**

**e) So Susana Vexler has no legal basis to include in her estimate from NP the Doors Ltd the replacement of a lock, which includes 7 bolts, 5 keys, and an interactive cylinder for 1900 NIS.**
