Petition Protection Order against Susana Vexler Page 1 of 4

I, Elana Laham, am requesting a protection order against Susana Vexler for as long as the law allows, which is six months to include prohibiting Susana Vexler from putting her trash on my side of the hallway.

(See Harassment Law Section Six Period Validity)

I, Elana Laham, intended to file for a protection order against Susana Vexler immediately after my previous protection order against Susana Vexler expired on August 13, 2018. However, I became ill and so was not able to until now.

The following are the reasons why I am petitioning for a protection order against Susana Vexler:

This is the third protection order I am requesting against Susana Vexler because she violated the other two protection orders I had against her by a) addressing a threatening note to me and b) vandalizing my porch and front door with eggs and c) leaving her trash on my side of the hallway and d) making contact with me.

A) On August 13, 2017, Judge Zahava Baner ruled a verdict for a one-year extension to a Mutual Protection Order between Susana Vexler and Elana Laham that was valid until August 13, 2018, which states the following:

"We agree with the court's recommendation that an administrative order be issued prohibiting either party from accessing the other's apartment or placing <u>garbage</u> in the section next to the other's apartment door, prohibiting either party from <u>harassing</u>, <u>threatening</u>, or <u>disrupting</u> its daily routine. This order shall be in effect for 1 year from now."

1) July 18, 2018, Susana Vexler violated the Protection Orders by writing a threatening note to me that reads, "The law of boomerang has not been cancelled yet!"

Susana Vexler's threatening note implies she will continue to harass me in violation of my protection orders against her. Susana Vexler's threatening note is vague. The threat can mean anything from vandalizing my property to stealing my belongings to murdering me. It is a crime to make threats.

2) July 18, 2018, Susana Vexler violated the Protection Orders by throwing eggs on my apartment's porch and front door.

3) July 20, 2018, Susana Vexler violated the Protection Orders by putting her trash on my side of the hallway.

I have proof the trash is not mine. The trash contents are white grain crackers and white grain noodles. I am allergic to white grain. It makes me constipated.

On July 24, 2018, I filed a Police Report against Susana Vexler for violating Court Orders by threatening me, vandalizing me, and putting her trash on my side of the hallway.

4) July 29, 2018, Susana Vexler violated the Protection Orders by making contact with me.

At about 4:20 in the afternoon I heard noises in the hallway. I looked thru my apartment front door's peephole to see what was happening. I saw Susana Vexler standing in front of her apartment's front door and a man with a ladder going to the roof. I opened my apartment's front door and took a photo of him because I did not know why he was there and since the last time Susana Vexler had males enter my side of the hallway they vandalized my side of the electric box. My spouse was with me. After I snapped the picture of the unknown male, Susana Vexler laughed. Then, the male said something to me in Hebrew I did not understand. So I told him, ''I do not understand you. My Hebrew is limited. Do you speak English?'' After that, before he was able to answer me, **Susana Vexler said to me in perfect English, "This is what he said to you..."** We did not hear anything else she said because my spouse and I went into my apartment and closed my apartment's front door.

B) On May 14, 2017, Judge William Hamed ruled a verdict for a three month Mutual Protection Order between Susana Vexler and Elana Laham that was valid until August 14, 2017, which states the following:

We agree with the court's recommendation that an administrative order be issued prohibiting either party from accessing the other's apartment or placing <u>garbage</u> in the section next to the other's apartment door, prohibiting either party from <u>harassing</u>, <u>threatening</u>, or <u>disrupting</u> its daily routine. This order shall be in effect for 3 months from now."

1) June 16, 2017, Susana Vexler violated the Protection Order by putting her trash on my side of the hallway.

On June 25, 2017, I filed a Police Report against Susana Vexler for violating Court Orders by putting her trash on my side of the hallway.

Three months after I moved into my apartment, on November 25, 2015, Susana Vexler put her trash on my side of the hallway. Her trash brings coach roaches into my home.

I have proof the trash is not mine. The trash is blocking my entrance and my exit to and from my apartment. It is not blocking Susana Vexler's entrance and exit to and from her apartment.
